● NAYLAND'S first carnival and Donkey Derby was a gratifying success for its organisers, the Village Hall and Recreation Ground Committee, which celebrates its anniversary in November.

When expenses are met the committee hope to have £400 towards their preliminary target of £7,000.

Every donkey race had its drama and there were many falls but no broken bones. Stewards caught donkeys who had thrown their riders.

Floats in the decorated procession included an entry from the Jane Walker hospital at Wiston. The winning entry from the Nayland Anchor, picturing workmen on Nayland's new

The first of the Fairs

Minutes of the meeting of the Nayland with Wissington Community Council held at the Mission Hall, Nayland, on Thursday, 6th July 1967, Mr. G. Jones in the Chair:-

Willingale (Congregational Church), Mrs. Rumble (Old People's Club), J. Norris (British Legion), J. Curtis (Football Club), Mrs. M. Halls (Community Council), Mr. J. Croft (Treasurer).

Apologies were received from Major-General Fairbanks and Messrs. Hopewell, Knox and Hines.

Minutes of the previous meeting were read and approved.

A discussion took place about the need for every organisation to help the Community Council and it was proposed by Mr. Croft and seconded by J. Curtis that the Council organise a series of Whist Drives commencing in the autumn and that every organisation in turn helps in running the event while the others provide the prizes.

The Treasurer reported that the total funds of the Council amounted to £648 11s.10d.

A general discussion ensued regarding arrangements for the Carnival & Donkey Derby and from this (the following) suggestions and proposals were forthcoming:

Proposed by Mr. K.G. Willingale and seconded by Mr. Croft that Mr. P. Chennery be asked to organise a Beer Tent - CARRIED.

Proposed by Mr. Croft and seconded by Mrs. Halls that Mrs. Hetherington be asked to organise a Tug-of-War across the River Stour - CARRIED.

Proposed by Mrs. Dryden and seconded by Mrs. Halls that the Raffle top prize be £25 and that 2,000 tickets be printed - CARRIED.

Further suggestions included a Balloon Race, and that a Celebrity be approached to head the list of judges of the Carnival Procession entrants. Mr. Atkins suggested that we consider a Jeep Assembly Display by the Army Cadets for this year or in the future.

It was proposed by Mrs. Halls and seconded by K.G. Willingale that Mrs. Hetherington should proceed with organising an Xmas Concert for the 7th and 8th December.

The date of the next meeting would be 17th August 1967, at the Mission Hall, Nayland.

This concluded the business.

Minutes of the FIRST ANNUAL GENERAL MEETING of the Nayland with Wissington Community Council held on Tuesday, 28th. November, 1967 at the Church Hall, Nayland.

APOLOGIES FOR ABSENCE received from Mr.Dyble, Mr.Dunlop and Mr.Ferguson.

The Chairman expressed sympathy to Sir Joshua and Lady Rowley on their recent accident and expressed the wish that a letter be sent to them hoping that a quick recovery would be made.

ANNUAL REPORT AND ACCOUNTS (Circulated)

The full financial report was given by the Treasurer, Mr.Croft, who stated that expenses for the year 1966/67 totalled £4.10.-. Dr.Cook remarked on the low administrative costs and called upon the Chairman of the Community Council to comment on the Annual Report. Maj.General Fairbanks told how the C.C.works. It is the joining together of all bodies within the Vilages, deciding on essentials and priorities, Recreational, Social and Charitable. The Annual Report had been circulated and the Chairman paraphrased and enlarged on the headings. The estimated cost of a village hall and recreation ground is £20,000 - £24,000. Offers have been negotiated for the land. The Community Council was registered as a charitable organisation on 28th.September 1966. The full C.C. had met on 4 occasions and the Executive Committee on 12 occasions. Gratitude was expressed to the Hon.Legal Adviser and Hon.Auditor for their work during the first year. The C.C. was now finding its feet and great advantages were found by working together. The chairman thanked all those who had helped so generously over the past year. Dr.Cook then thanked the chairman of the C.C. for the exposition of the Annual Report. Mr.Duffield proposed the adoption of the accounts and annual report, seconded by Major Hopewell and carried Nem.Con.

Nayland fair is top Whit attraction

WHIT-Monday will see one of the most colourful West Suffolk festivals in one of its most delightful villages. It is of course Nayland fair.

In the 15th century the village of Nayland was, after Lavenham and Boxford, the next most important centre of the wool trade in the "Hundred of Baberg", at that time by far the most prosperous "Hundred" in Suffolk.

The inhabitants celebrated yearly the Feast of Floralia at Whitsun. The festivities started at dawn with a procession through the narrow streets and the roistering and feasting continued through the day in and around the village market, where food, ale and goods for sale were available and where rough country contests took place.

It is not proposed to start Nayland's Fair this year at dawn but at 2.15 p.m., but it will also begin with a grand decorated procession through the village and there will also be the village market and certain contests for strong and thirsty men.

Side-shows, talking dolls

and magic, the Bugle Band from H.M.S. Ganges, afternoon teas and refreshments will provide a variety of entertainment for old and young alike.

Two special features will be:—a display and sale of woven goods, made in Nayland, by the two remaining followers of its ancient craft, including an exhibition of goods by Peter Collingwood.

Mr. Collingwood has been invited to exhibit his work at the Victoria and Albert Museum in January, 1969, and he is at present on a tour of Canada and the United States giving workshop demonstrations of his craft. He is shortly to publish a book on weaving—secondly, an art exhibition and sale of paintings by local artists. This will include a work by John Nash, R.A., of Ronald Barrad.

A "Dwile Flunking" contest is included in the programme of events. This has its origins from the days of the height of the weaving greatness of Suffolk, and is based on the habit of customers in the ale-houses throwing the Dwile (or Dolly), a woollen mop, at the Flunker (or Flunkey) if he was careless in mopping spilt ale on the tables.

Mention has been made of the Feast of Floralia. The custom of celebrating this feast had its origins in the very distant past when our pagan ancestors offered blood sacrifices in order that the harvest should be plentiful.

In the 15/16th Century when this celebration took place the streets of Nayland must have presented a very attractive sight each shop with its sign. The Bush over the ale house, the Ivy on tavern hanging basins over the barbers' shops, and the Weavers' houses decorated with a Bishop's Mitre and Fleur de Lys, the sign of St. Blase, their patron Saint.

Although many things have changed since then Nayland remains a beautiful village full of old houses and cottages and the village centre lays unspoilt by the march of time.

The fair on Whit Sunday is being organised by the Nayland with Wissington Community Council.

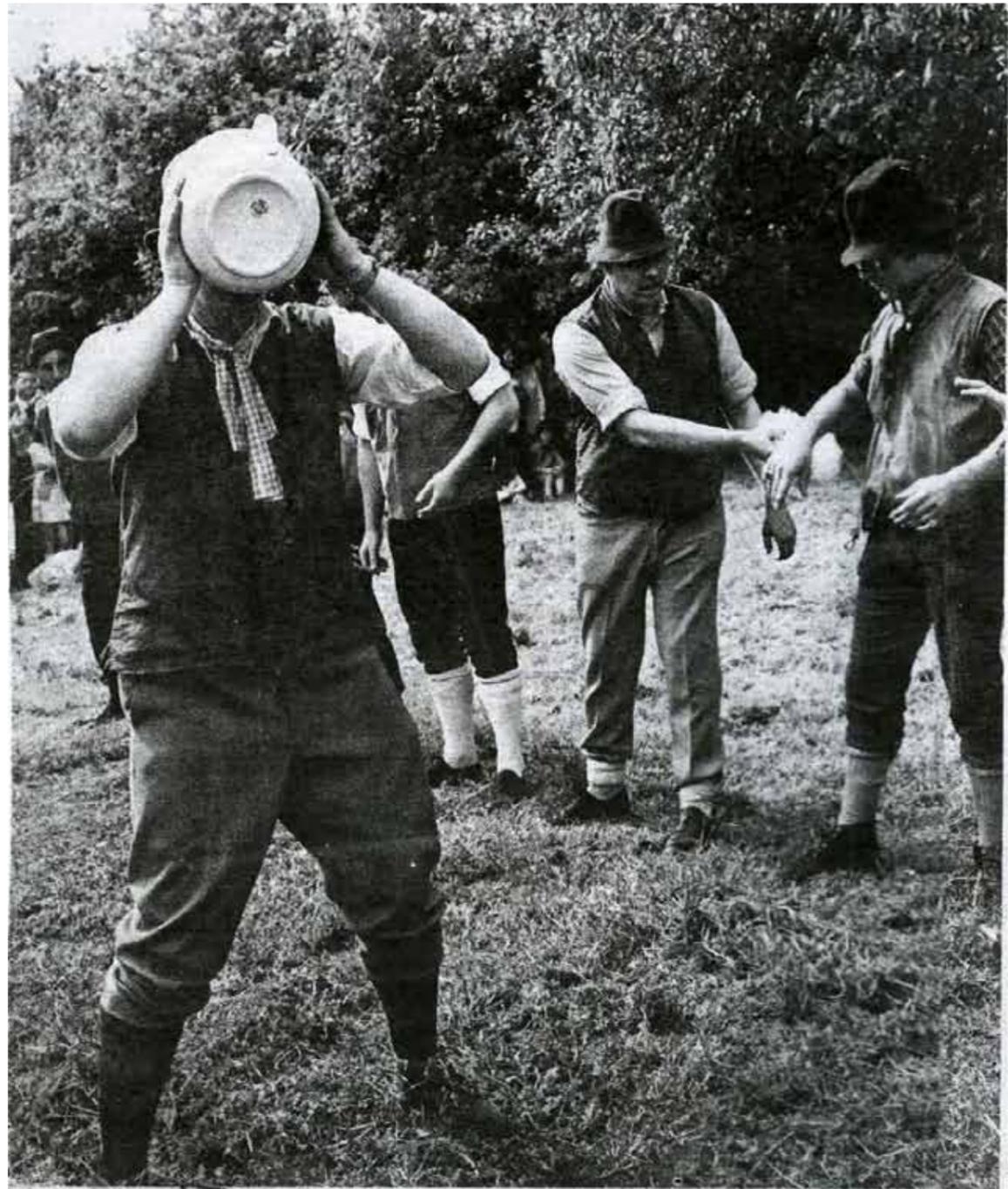
NAYLAND'S WHITSUN FLORALIA

Annual Report 1967-1968

General

1. The first Annual Report of the Council began by outlining the circumstances which led to its formation. This need not be repeated, but it may be worthwhile to mention, once again, the two immediate priorities, the provision of a Recreation Ground and building a Village Hall, and to see what progress has been made in achieving these objectives.

2.(a) Recreation Ground. During the year under review both the Community Council and the Parish Council in turn entered into negotiations to purchase Webb's Meadow. When these attempts at direct purchase failed, the Parish Council, as a result of a decision taken at a Parish Meeting, asked the County Council to obtain Webb's Meadow for use as a Recreation Ground by means of a Compulsory Purchase Order.

2.(b) Under these circumstances it was reasonable to assume that, in due course, Webb's Meadow would become available for use as a Recreation Ground and therefore action was taken by the Community Council to obtain grants from the Department of Education and Science and the County Council to meet some of the cost of purchase of the land and for a modest amount of equipment necessary for its upkeep.

3.(a) Village Hall. At one stage during the year, when it appeared that all efforts to obtain Webb's Meadow and build a Village Hall thereon were likely to fail, an approach was made to the Parish Council to site a Village Hall on Fairfield Playing Field. Outline planning permission for this was obtained and legal negotiations with both the Parish Council and Parochial Church Council were about to open when the project was put in abeyance as a result of the new situation arising from the action of the Parish Council to obtain Webb's Meadow.

3.(b) It is now possible to revert to the original intention and plan to build the Village Hall on Webb's Meadow.

4. Costs (a) It may be some time before the amount to be paid for Webb's Meadow is known. The present intention is, however, that a special Trust should be set up with the Parish Council as Trustees, to be responsible for the future management of the Recreation Ground and that funds, both for the purchase of the ground and its upkeep, should be made available to this Trust by the Community Council.

(b) Providing the assumption as to the purchase price is reasonably accurate, and providing the grants from the Department and County Council are obtained, the Community Council is in a position now to finance this purchase and still have a substantial balance towards the provision of a Village Hall.

5. Time Factor When the Council was set up it was assumed that it would take five years at least of concerted effort to raise the very substantial sum required to purchase and equip both a Recreation Ground and a Village Hall. This target date is still realistic, but only if the Council's member organisations and all members of the Community continue to give their active support in raising funds. Indeed, if renewed effort can be stepped up the two projects could be achieved in the first four years of the Council's existence.

6. Events The Council is most grateful to those member organisations and individuals who ran special money raising events on its behalf. Although the list is a shorter one than last year's it is well to remember that nearly all member organisations were deeply involved in providing the very successful stalls for the Fair.

7. Fair The Fair on 2nd May was financially more successful than the Carnival of the previous year, despite the lack of any satisfactory open space to allow for variety and facilities. The Council is most grateful to its member organisations and the many individuals who played their part in reaching such a satisfactory net gain of £463. 15. 4d.

8. Finances The accounts for the year 1967-68, subject to audit, are attached.

9. It will be seen that our accumulated funds, as at 30th September 1968, amounted to £2,466. 7. 9d., having increased during the year under review by £1,315. 18. 9d. as compared with the previous year's total of £1,150. 9. 0d.

10. To the sum of £2,466 can be added the £500 promised by the Rothley Trust, which will become available as soon as the cost of purchasing Webb's Meadow is known. Furthermore, it has always been assumed that the funds of the old Village Hall Trust, approximately £900, will be made available to meet some of the cost of building the Village Hall.

11. Investments have been made since the year 1971-72; It is proposed, therefore, that at the appropriate moment a loan of £1,000 from the National Playing Fields Association will be applied for. These loans are normally granted for a 10 year period at very low interest rates.

12. Two points in the accounts are of particular interest. First that expense on administration has been only £3. 2. 6d for the year and secondly that the Nest Egg has brought in £609. This is the best means of an assured income and it is to be hoped that during our third year we can greatly increase the number of weekly tickets sold.

13. Acknowledgements. The Council's thanks go to its Honorary Officers, Officers and Members of the Executive Committee for their continuing support and, in the case of the latter, their regular attendance at its many meetings during the year.

14. The Council is most grateful to Mr. Kirby for continuing to act as the Council's Honorary Auditor.

15. Mention must be made of the individual donations received during the year and to extend our thanks to those concerned.

16. Conclusion. The Council is well on its way to achieving the two aims for which it was established. Success can be achieved only if it has the continuing full support of its member organisations and the general public of Mayland & Wiston.

Conditions relating to this permission

SUBJECT TO THE FOLLOWING CONDITIONS:-

1. Before any development takes place the prior approval of the Local Planning Authority shall be obtained in respect of any matters relating to the layout, siting, design and external appearance of any buildings to be erected or the means of access thereto
2. Before any development takes place precise details of the siting of the proposed Hall shall be agreed with the Local Planning Authority and such siting shall have regard to the need to safeguard the amenities of existing and proposed residential properties in the immediate vicinity.
3. Before the proposed building is brought into use car parking provisions shall be made within the site in accordance with the standard requirements of the Local Planning Authority.
4. Before any development takes place a tree planting scheme shall be submitted to and approved by the Local Planning Authority, such tree planting to be carried out during the planting season October/March immediately following the commencement of development. The reasons for the Council's decision to grant permission for the development, subject to compliance with the conditions hereinbefore specified are:-
 1. To secure orderly and well designed development and in the interests of road safety.
 2. To safeguard the amenities of the locality.

Dear Mr. Lawrence,

Nayland-with-Wissington Playing Field

Mr. Hill has told me of your enquiry regarding the control of the playing field which you have recently acquired with grant aid from the Ministry of Housing and Local Government and your Community Council.

You are now faced with the layout of the site as a playing field and to provide a site for a village hall.

If Nayland is to take advantage of the grants available it will be necessary for your parish council to lease the site to a voluntary organisation such as the Community Council so that it may apply for a grant to lay out the land as a playing field and separately for the purpose of providing a village hall on part of the site. The lease must be for a minimum period of 28 years.

This necessitates two leases as grants for playing field are made to voluntary organisations by the Ministry of Housing and Local Government and grants to village hall committees by the Department of Education and Science.

You may care to contact General Fairbanks on these matters as he is well versed in this rather complicated procedure. General Fairbanks has copies of the playing field and village hall draft legal documents. Model draft documents are, however, available from this office.

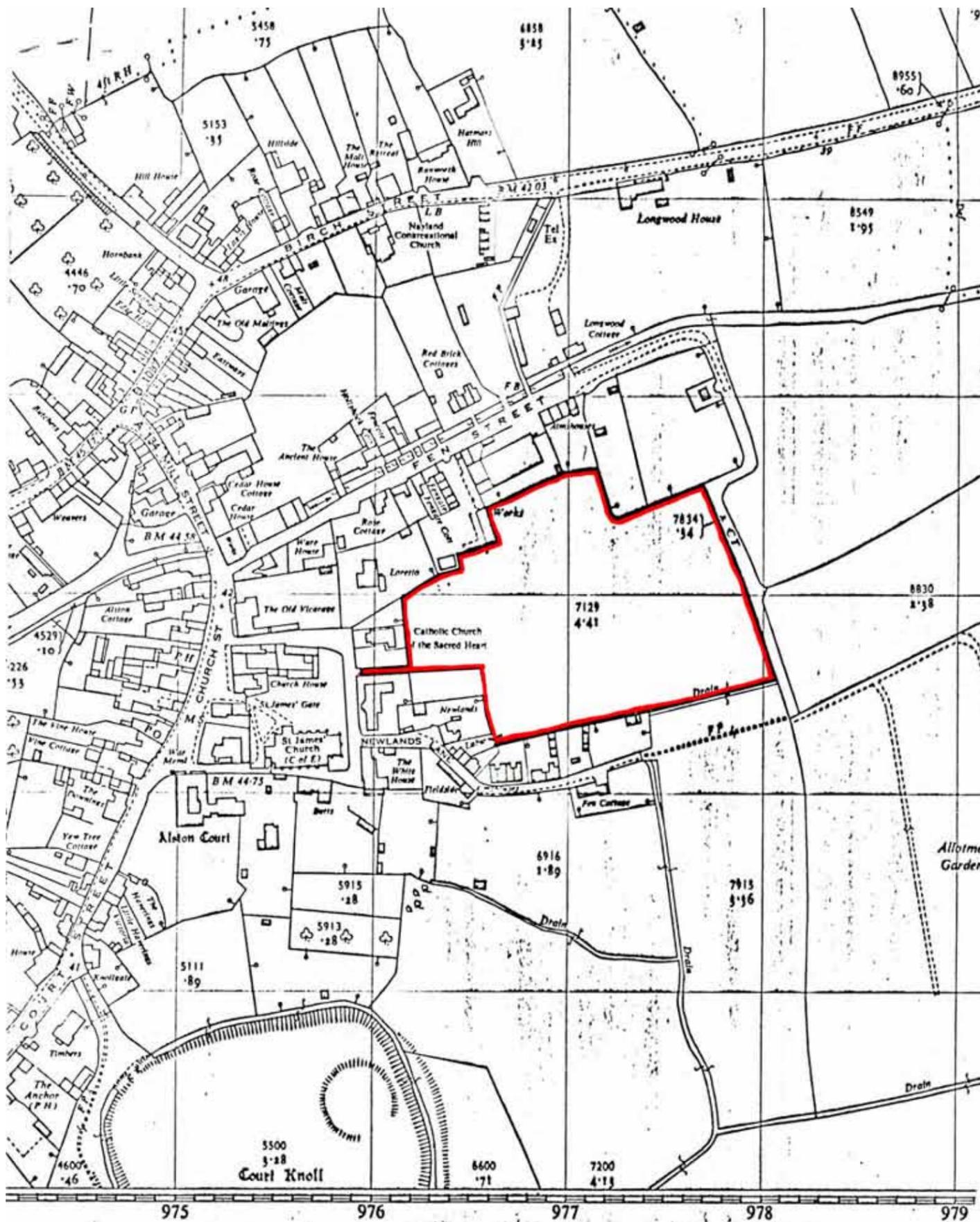

Army (Retired) and KENNETH GEORGE WILLINGALE of 3 Willow Grove Nayland aforesaid Merchant Banker (hereinafter called "the Tenants") of the other part

WHEREAS

- (1) the Council is the freehold owner of land situate in the Parish of Nayland with Wissington known as Webbs Meadow
- (2) the Council is empowered to let the said land by the provisions of Section 4 of the Physical Training and Recreation Act 1937

NOW THIS LEASE WITNESSETH as follows:

1. IN consideration of the rent and the covenants by the Tenants hereinafter reserved and contained the Council hereby demises to the Tenants ALL THAT piece or parcel of land (hereinafter called "the land") situate in the Parish of Nayland in the County of Suffolk known as Webbs Meadow consisting of part of the enclosure numbered 7129 on the Ordnance Survey Map for the said Parish (1960 Edition) and shown for identification purposes only edged red on the plan annexed hereto TO HOLD the same unto the Tenants upon the Trusts set out in the First Schedule hereto and for no other purposes for the term of sixty years from the Fourteenth day of October One thousand nine hundred and sixty-nine PAYING therefor during the Tenancy the rent of Five pounds on the Fourteenth day of October in each year the first such payment to be made on the Fourteenth day of October One thousand nine hundred and seventy
2. THE Tenants hereby covenant with the Council:
 - (a) To pay the said rent on the said days
 - (b) To maintain the land in good condition and to keep all buildings and other structures standing thereon at the date hereof or hereafter during the tenancy placed thereon in good and tenantable



repair and to do all necessary repairs to the walls fences hedges gates and other means of enclosure of the land

- (c) Not to erect any buildings upon the land during the tenancy without the consent of the Council in writing being first obtained other than a Village Hall and Sports Pavilion for which detailed plans shall first be approved in writing by the Council
- (d) Not to assign the tenancy in whole or in part nor to part with the possession of the land or any part thereof during the tenancy to any other person or body whatsoever (without the consent in writing of the Council) provided that the Tenants shall not be in breach of this covenant if at any time without such consent they shall allow any sports club or other body or persons organized or assembled for recreational purposes or other purposes to have the exclusive use of the land and buildings or any part thereof where the said use is allowed only for such period as is reasonable for the game or activity or assembly to be played or carried on or to be gathered
- (e) To pay all rates taxes charges assessments and outgoings assessed charged imposed or levied upon the land or the buildings thereof
- (f) To remove at the expiry of the tenancy if the Council so requires any building erected during the tenancy
- (g) To make good any damage caused by the said removal or by removal pursuant to the power granted by the Council's covenants hereinafter set out

3. THE Council hereby covenants with the Tenants that:

- (a) The Tenants shall at all times be at liberty to remove from the land any buildings or structures erected during the tenancy
- (b) The Tenants paying the rent and performing the covenants on their part hereinbefore set out shall peaceably hold and enjoy the land during the tenancy without any interruption by the Council or by any person claiming by or under it

IN WITNESS whereof two members of the Council on behalf of the

Council and the Tenants have hereunto set their hands and seals the day and the year first before written

THE FIRST SCHEDULE

1. The Tenants shall apply as soon as possible to the Charity Commissioners through the Secretary of State for Education and Science for an Order of the Charity Commissioners for England and Wales vesting the trust property hereby demised (hereinafter called "the Trust Property") in the Official Custodian for Charities and upon such Order being made the Tenants shall cease to be the trustees of the Trust Property and the Charity shall thereafter be administered and managed by the members for the time being of the Committee of Management hereinafter mentioned as the Trustees thereof
2. The Trust Property shall be held upon trust for a recreation ground and for the erection of a Village Hall and Sports Pavilion for recreational purposes for the benefit of the inhabitants of the Parish of Nayland with Wissington in the County of Suffolk in such manner as the Committee of Management from time to time shall think fit
3. The general management and control of the Trust Property and the arrangements for its use shall be vested in a Committee of Management (hereinafter called "the Committee")
 - (a) Five Elected Members of the Committee shall be elected at the Annual General Meeting to be held as in this Deed provided for a term of office commencing at the end of the Annual General Meeting at which they are elected and expiring at the end of the Annual General Meeting in the following year
 - (b) Twenty-two Representative Members of the Committee shall be appointed by such appointing organizations as are set out in the Second Schedule and their names shall be notified by each appointing organization to the Secretary of the Committee. They shall except in the case of such members appointed to fill casual vacancies be appointed before the Annual General Meeting in any year for a term of office commencing at the end of the Annual General Meeting next after their appointment and expiring

at the end of the Annual General Meeting in the following year

(c) The Committee shall have power to co-opt not more than five members to hold office until the end of the Annual General Meeting following their co-option

(d) Any competent member of the Committee may be reappointed or re-elected

4. The Committee at its first meeting in each year after the Annual General Meeting shall elect one of its number to be Chairman of its meetings and may elect one of its number to be Vice-Chairman. The Chairman and Vice-Chairman shall continue in office until their successors are respectively elected

If the Chairman is absent from any meeting the Vice-Chairman (if any) shall preside otherwise the Members present shall before any other business is transacted choose one of their number to preside at that meeting

5. Every matter shall (except as provided in this deed) be determined by the majority of the members of the Committee present and voting on the question. In case of equality of votes the Chairman of the meeting shall have a second or casting vote

6. There shall be an Annual General Meeting to be convened by the Committee in the month of March in each year the first of such meetings (herein called "the first General Meeting") to be convened in the month of

1970 by 21 days' notice to be affixed to some conspicuous part of the Trust Property or other conspicuous place or places in the said Parish of the inhabitants of the age of 18 years or upwards of either sex for the purpose of receiving the Report and Accounts of the Committee and for accepting the resignations of members of the Committee and for the purpose of electing five members under Clause 3 hereof and for taking such action as it may decide under Clause 9 hereof provided nevertheless that if in any year an Annual General Meeting shall not be convened and held in the month of March, the Annual General Meeting for that year shall be held as soon as practicable after the month of March

7. The Committee shall have power by Resolution of the Committee

passed at a meeting at which not less than two-thirds of all the members of the Committee vote in favour of the Resolution to allow any existing organization in the said parish not mentioned in the Second Schedule hereto and any other organizations which may hereafter be formed in the said parish having aims of a recreational character consistent with those upon which the Trust Property is held hereunder to appoint an additional member of the Committee in the same manner as if such organization had been mentioned in the Second Schedule hereto and for this purpose the total number of members of the Committee as provided for in Clause 3 hereof may be increased but no Resolution shall be effective until it has been approved in writing by the Secretary of State for Education and Science

8. A casual vacancy arising from the death or resignation or removal of an appointed member of the Committee shall be filled by the organization by which such member shall have been appointed and the person so appointed shall retire at the time when the vacating member would have retired. In the event of a vacancy arising through the death resignation or removal of a member of the Committee elected by the Annual General Meeting the Committee shall have power to fill such vacancy until the next Annual General Meeting. All members shall retire annually at the Annual General Meeting

9. If any organization entitled to appoint a member of the Committee ceases to exist or fails to make an appointment in manner aforesaid before the Annual General Meeting in any year the Annual General Meeting shall decide in what way if at all the vacancy shall be filled

10. The proceedings of the Committee shall not be invalidated by any vacancy amongst its members or by any defect in the appointment or qualification of any member

11. The Committee shall keep a Minute Book and books of account. All proper statements of account shall be prepared each year as prescribed by section 32 of the Charities Act 1960 and after the erection of the said Village Hall and Sports Pavilion copies thereof shall be sent to the Council

12. The Committee may from time to time make and alter rules for the

conduct of its business and for the summoning conduct and recording in the Minute Book of its meetings and in particular with reference to:

- (a) The terms and conditions upon which the Trust Property may be used for recreational and the sums (if any) to be paid for such use
- (b) The appointment of an Auditor Treasurer and such other unpaid officers as it may consider necessary and the fixing of their respective terms of office
- (c) The engagement and dismissal of such paid officers and servants for the Trust Property as it may consider necessary
- (d) The number of members who shall form a quorum at its meetings provided that the number of members who shall form a quorum shall never be less than a third of the total number of members of the Committee

13. All payments in respect of the use of the Trust Property and all donations for the benefit thereof shall be paid into a Trust Account at the National Westminster Bank at High Street Colchester or at such other Bank as shall from time to time be substituted by the Committee any such substitution to be endorsed upon this Trust Deed with a copy of the resolution relating thereto

14. The moneys standing to the credit of the said Account shall be applied as the Committee shall decide in maintaining repairing and insuring the Trust Property and the buildings and effects thereon and in paying rent rates taxes salaries wages and other outgoings and in providing equipment and means of recreation and otherwise for the maintenance and improvement of the Trust Property and any sum not needed as a balance for working purposes shall be invested in the name of the Official Custodian for Charities

15. The Committee may upon the vote of a majority of its members and with the consent of the Secretary of State for Education and Science from time to time by mortgage or otherwise obtain such advances on the security of the Trust Property or any part thereof as may be required for maintaining extending or improving the same or any part thereof or erecting any building

thereon or for the work carried on thereon and may continue or repay in whole or in part and from time to time any existing mortgage or charge on the said property

16. If the Committee by a majority decides at any time that on the ground of expense or otherwise it is necessary or advisable to discontinue the use of the Trust Property in whole or in part for the purposes hereinbefore indicated it shall call a Meeting of the inhabitants of the age of 18 years or upwards of the said Parish of which Meeting not less than 21 days' notice (stating the terms of the Resolution that will be proposed thereat) shall be posted in a conspicuous place or places on the Trust Property and advertised in a newspaper circulating in the said Parish and if such decision shall be confirmed by a majority of such inhabitants present at such Meeting and voting the Committee may with the consent of the Secretary of State for Education and Science let or sell the Trust Property or any part thereof. All moneys arising from such letting or sale (after satisfaction of any liabilities properly payable thereat) shall with such consent as aforesaid be applied either in the purchase of other property approved by the Committee and to be held upon the trusts for the purposes and subject to the provisions hereinbefore set forth (including this power) or as near thereto as circumstances will permit or towards such other charitable purposes or objects for the benefit of the inhabitants of the said Parish as may be approved by the Secretary of State for Education and Science and meanwhile such moneys shall be invested in the name of the Official Custodian for Charities and any income arising therefrom shall either be accumulated (for such time as may be allowed by law) by investing the same and the resulting income thereof in like manner as an addition to and to be applied as the capital of such investments or shall be used for any purpose for which the income of the Trust Property may properly be applied

17. If any Rules made under the power in that behalf hereinbefore contained are inconsistent with the provisions of these presents the latter shall prevail

I enclose a copy of the proposed draft Lease as promised, and I also return the National Council of Social Services Model B document, which I found useful.

I preferred the precedent given in the National Playing Fields Association's booklet, so that is the one I have primarily followed, although I have made some amendments to it which are prompted by the Model B precedent and also by the special circumstances of the transaction.

I am sending copies of the draft to all the members of the Parish Council and I will present Gerald Jones with 22 copies for the Community Council representatives. In addition I am sending copies now to the Legal Branches of the Department of Education and Science and the Ministry of Housing and Local Government so that they can start thinking about the document, which I fear will be a slow business.

GENERAL

1. Early in the year the remainder (£1280) of the total loan of £2100 to the Parish Council, in respect of the purchase of Webb's Meadow, was made. As the Councils Cash at Bank was insufficient to meet this sum a loan was obtained from the Bank rather than realising on Investments before their redemption date. The Bank loan was soon repaid but this factor should be remembered in considering the accounts for the year.

2. It had been hoped that a provisional Offer of loan, from the Department of Education and Science, towards the cost of the Village Hall project would have been received in Feb. 70. In the event this offer was not received until Aug. 70. This has not, in fact, delayed the date when building can be started, as it was always evident that the Council's own fund would not allow a start to be made before at earliest mid 71.

RECREATION GROUND

3. Arrangements were made by the Parish Council to hand over the management of the Ground to a Committee set up under a Trust whereby the land itself is held by the Official Custodian of Trust Properties under a Deed prepared by the National Playing Fields Association which allows for the representation of all Village Organisations and interests on the Management Committee.

4. As a result the Community Council has no responsibility for the Recreation Ground except in so far as it is represented on this Management Committee. However, as the latter has no funds, the Community Council provided the finances, during this year, to ensure that the grass was cut, as necessary, and other small improvements made.

VILLAGE HALL

5. Having now received a provisional grant offer of £7,655, based on an estimated overall cost of £16,211 the action required to meet the conditions on which the grant offer is made are now in hand. These include obtaining planning permission in detail, and obtaining tenders from the building trade.

6. The date when building can begin depends very much on how accurate the estimated cost, as arrived at by our architect over a year ago, is when compared with actual tenders received for the construction and necessary equipment.

9. In July 70 the Charity Commissioners approved a Scheme whereby the funds of the old V.H. Trust may be transferred to the Council in or towards providing land and buildings for use as a Village Hall.

10. When the Parish Council set up the Management Committee referred to in para. 3 provision was made in the Deed to give this same Committee responsibility for the management of the Village Hall, when completed.

FINANCE (see Audited Accounts)

11. As before the two largest items of income were from the Nest Egg and Market Fair. It is, however, disappointing that the income from the Nest Egg has fallen just when the Council is poised to complete the second of its major tasks. It is hoped that all organisations forming the Council will do their utmost to increase the numbers who support the Council by means of this weekly draw.

12. The net income from the Fair was £453 and might easily have topped the £500 mark had it not been for rain during the morning and a serious loss of potential income because so many cars were allowed to park in the streets despite the Police "No Parking" signs.

13. In considering the future policy of the Council in relation to when a start can be made in building the Village Hall it must be borne in mind that there is the sum of £800 owed to the Parish Council and to be found over the next ten years which can not be set against the loan made to the Parish Council of £2,100 repayable over sixty years.

CONCLUSION

14. The Council wishes to thank, once again all those who have given their support, in so many ways, during the year.

15. It has been a great pleasure to those who have worked so hard for the Council over the past four years to see the Recreation Ground in use and beginning to fulfil its purpose. It will take time to develop its full potential but we can, at least, be assured that the ground is secure for the future.

General

3. After considerable delay the Trust Deed establishing the Committee was finalised on 8th January, 1971 and the necessary action was taken to transfer the Committee's Property from the two Trustees into the hands of the Official Custodian of Trust Properties for a period of 60 years as from 14th October, 1969.

Executive Committee.

4. This Committee has met three times and has discussed the future development of the Playing Field and has promulgated simple provisional rules for the use of the field.
5. The Executive Committee appreciated that development of the field for activities, other than football, must depend on the formation of groups, within the Parish, interested in organising such activities as tennis, bowls, cricket etc. and that it must rest with individuals to get such groups or clubs established and raise funds towards the provision of the necessary equipment etc.
6. In the meantime the Community Council had provided £80 in 1969/70 for cutting and minor improvements to the field and had promised the sum of £70 for the upkeep of the ground in 1971 in addition to paying the £10 (£5 p.a.) rent due to the Parish Council.

Finances.

7. The only income received has been in connection with charges for use as a Car Park - total £8. There have been no expenses as these have been met by the Community Council.
8. The two football teams using the field will, at the end of the season, be expected to provide further funds for the account.

Future Plans.

9. When the Community Council has built the Village Hall on the field and handed over its management to this Committee it should then be possible to make detailed plans for the development of activities, other than football.
10. In the meantime the Committee will take action as follows:-
- (a) Encourage the formation of Groups or Clubs referred to in paragraph 5.
- (b) Set up a Sub-Committee to prepare for the future task of managing the Village Hall so that as soon as this is opened there will be no delay in ensuring its success both as a centre of Village Social and recreational life but also as a viable financial undertaking.

3. At a meeting on 26th August, 1971, the Committee formally resolved to make an application for an Order vesting the lease of the playing field and Village Hall in the Official Custodian of Charities. The formal application has subsequently been submitted.

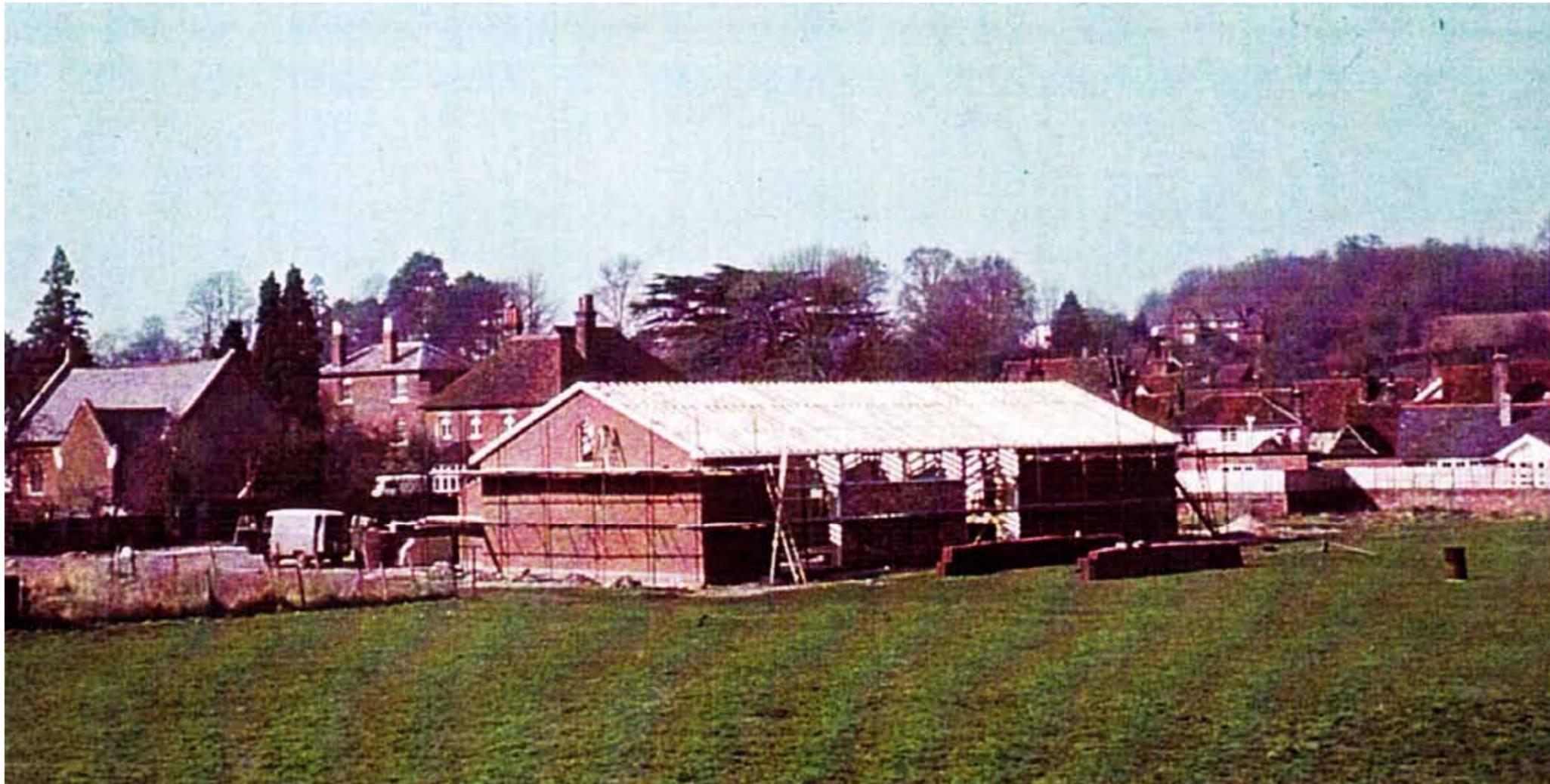
10. There has been no expenditure, since all expenses have been met by the Community Council. The total of £25 is accordingly carried forward to 1972/3.

The Village Hall Management Committee was established at a special Parish meeting on 7th May 1970. After considerable delay the Trust Deed establishing the Committee was finalised on 8th January 1971 and the necessary action was taken to transfer the property from the two Trustees into the hands of the Official Custodian of Trust Properties for a period of 60 years from 14th October 1969.

The Hall was officially opened on 5th August 1971; the Management Committee took over responsibility for the hall from the Community Council on the same day.

Merger could solve finance problem?

Nayland village hall management committee is hoping to go ahead with new projects involving the use of the hall, providing enough volunteers can be found to organise them.

When a public meeting to discuss new ideas was held last month, it was suggested that the hall could become a "white elephant" if it were not used more and made financially viable.

At an executive committee meeting last week it was agreed in principle to start a youth club but up to now only two people have come forward who are prepared to help run it. The committee decided to meet the four teenagers who put up the idea last month to discuss the project.

Members were also very keen to use the hall for amateur dramatics but volunteers were again needed to run such a project. Two other suggestions — film shows and ballroom dancing — were still being investigated. They agreed to the idea of letting the hall hourly for badminton.

It was reported that the recent Music Week had been very successful and it was hoped to encourage this type of event in future.

On the question of the hall's finances the committee decided to arrange a meeting with the community council to discuss them. Last month it was suggested that the hall's financial problem could be resolved if the committee and the community council were to merge.

Nayland aid for Youth Club

Nayland Community Council has awarded a grant of £50 to the newly-formed village youth club. This was decided at a council meeting in the village hall on Wednesday last week.

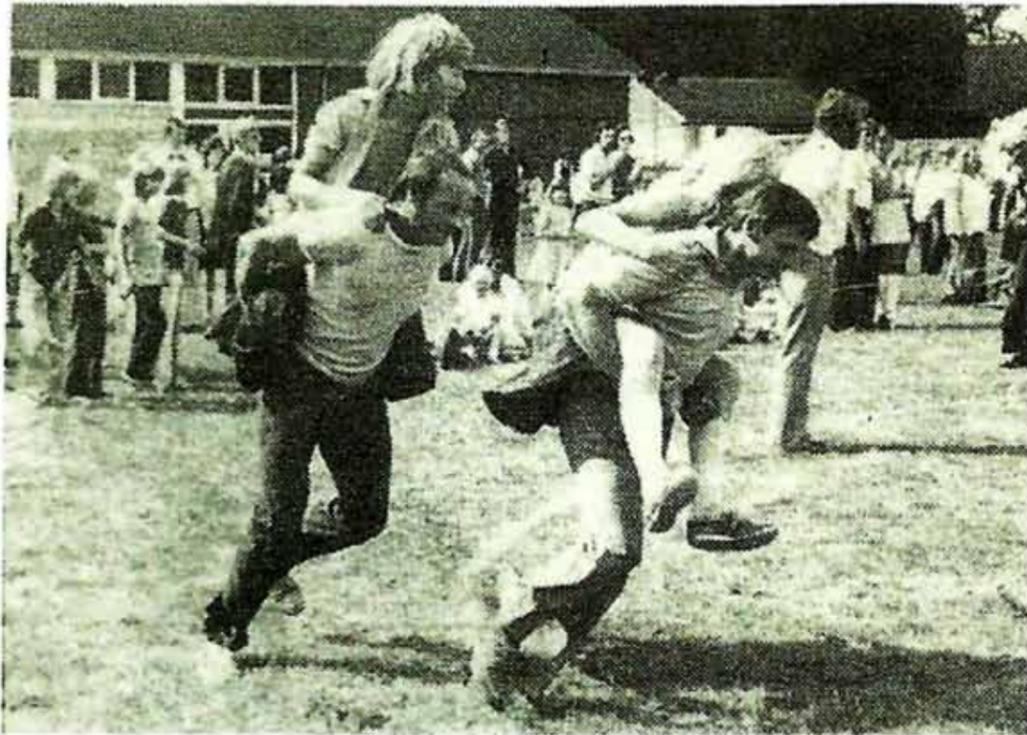
The club had asked for £100, but it was pointed out that there was still £30 in the bank and some sports equipment left over from the old sports club which closed three years ago. Members hoped that the club would still ask for further financial help if it were needed.

The council also agreed to help the village hall management committee with a subsidy towards the hall's heating and to finance an investigation into various ways of improving the heating arrangements. The amount of the subsidy will be decided when the investigation is completed.

Committee representatives had said organisations were reluctant to use the hall because the heating was inadequate and the committee did not want to raise the hiring charges to make it viable.

After discussion on the functions of the community council and management committee it was agreed that they should continue as separate entities. It was felt the council had a wider function and could deal with applications for funds.

The chairman, Mr. K. Willingale, stressed that the council was always willing to consider applications from local organisations for financial help.

Nayland Village Hall Management Committee has asked an architect to look into the question of improving the hall's heating.

This move, made at a committee meeting in the hall on Wednesday last week, follows a community council decision to finance such an investigation in an effort to make the hall more attractive to prospective hirers. The council also said it would help the committee by subsidising the electricity charges.

Explaining the council's decision, Mr. Ken Willingale, chairman, told the committee the council still had a considerable amount of money in its funds which it felt should be spent on improving the heating. The council wanted to keep the hiring charges down, at the same time maintaining the heating at a reasonable level.

It was willing to commission an architect to design some form of screen to partition the hall and to insulate the roof.

The committee agreed to a proposal by Mr. John Oakes to get the investigation started and Mr. John Davis was asked to carry out the work. Members also agreed to further proposals by Mr. Oakes to run a large storage heater daily instead of intermittently to inject some permanent heat into the building and to have a coin-box telephone installed on the premises.
